**RESOLUTION CALLING FOR THE APPROVAL OF THE APPOINTMENT OF
ANGELI ROXAS AS THE COMELEC COMMISSIONER FOR THE COLLEGE OF
BUSINESS**

Resolution for the appointment of the COMELEC Commissioner for the Ramon V. del Rosario College of Business for school year 2016-2017.

Whereas, The USG shall have the power of which emanates from the student body. It shall be the sole, unified, autonomous and democratic representative body of the students (University Student Government Constitution Article III, Section 1);

Whereas, the Legislative Assembly is the highest policy-making body of the University Student Government (University Student Government Constitution Article XIV, Section 1);

Whereas, the Rules & Policies Committee shall initiate the review of the rules, policies, and procedures of the Legislative Assembly, De La Salle University Student Government, and De La Salle University, in coordination with the concerned offices and/or units, and present recommendations to the Legislative Assembly, De La Salle University Student Government Executive Committee and offices concerned (LA Rules of Internal Governance Article VII, Section 3.1);

Whereas, there shall be an independent Commission on Elections (COMELEC) which shall decide on all electoral exercises within the university (De La Salle University Student Government Constitution, Article XIX, Section 13);

Whereas, the COMELEC shall be composed of two commissioners from each college of the University (De La Salle University Student Government Constitution, Article XIX, Section 14);

Whereas, the applicant for COB COMELEC commissioner Angeli Roxas has sent her resume to COMELEC (Appendix A);

Whereas, Angeli Roxas has never been placed under any academic or disciplinary probation, has never been a member of any political party, and does not currently hold any other Executive Board positions in any recognized student organizations in the university, and therefore meets the qualifications of a COMELEC commissioner (Election Code, Article IV, Section 3);

Wherefore, be it resolved that Angeli Roxas be appointed as the new COMELEC Commissioner for the Ramon V. del Rosario College of Business;
